PURPOSE AND SCOPE

The CEFC is seeking an Associate Director in the Investments team to manage stakeholder engagement with a broad range of counterparties, support the development of origination activities, and manage / deliver the execution phase of transactions (including internal credit processes and external client and legal matters) for a broad range of sectors which are an investment focus for the CEFC. The sectors are:

- Reef Funding Program (supporting the Federal Government's Reef 2050 plan);
- Manufacturing sector;
- Agriculture sector;
- · Universities; and
- Local Government;

The role is broad ranging in terms of sector focus and requires a flexible attitude to manage the variety of work activities involved in the role. A strong investment / transactional background with demonstrable commercial acumen is considered essential. Investment writing for credit assessment and excellent interpersonal skills is also required.

An understanding of the clean energy technologies/solutions that may be applicable to the focus sectors and issues affecting the Great Barrier Reef health are highly desirable.

DUTIES AND RESPONSIBILITIES

Sector Analysis and Early Stage Origination

- Attend briefings on sector analysis / potential projects / early stage concepts and be able to define the challenges or considerations for an investment and if/how CEFC could play a role.
- Able to meet with stakeholders / potential proponents independently and assess their viability/credentials and determine CEFC eligibility and investment proposition. Provide advice on next steps based on those meetings and initial assessment.
- Undertake sector analysis to inform CEFC strategy and deepen sector knowledge.

Transaction Execution

• Liaise with project parties to ensure a coordinated flow of information. This will require coordinating and managing multiple workstreams and people to achieve milestones by agreed timeframes.

- Managing the CEFC internal processes to produce investment approval papers, keep team members up to date as appropriate and manage feedback from credit/investment committee/Board etc.
- A high level of attention to detail to ensure the transaction continues to meet CEFC's requirements, demonstrating a high level of understanding of commercial/legal/financial issues and potential risks.
- Oversee transaction workstreams and resourcing allocated to the transaction to ensure transaction deliverables are met.
- Attend and present at Investment Committees and Board Meetings.

Other

- Travel required average of one trip per month, possibly for a few days at a time.
- Knowledge sharing ability to report and disseminate information to support CEFC's objectives

KEY SKILLS, KNOWLEDGE, EXPERIENCE AND QUALIFICATIONS

Investment Analysis Skills

- Credit and risk analysis strong risk assessment skills with the ability to assess credit risk and consider mitigations for risks
- Persuasive presentation skills the ability to present to a range of audiences to achieve outcomes, in both informal (meetings) and formal (investment committees) settings.
- Investment paper writing highly proficient investment analysis writing, critical / risk analysis, succinct presentation, simple explanation of complex items
- Financing Options understand wide range of financing options. Primarily debt (corporate), however knowledge of equity/convertible notes and "hybrid" structured arrangements would be beneficial.
- Commercial acumen understand the overall picture for the investment and the key drivers for decisions, and the associated risks or opportunities
- Analysis undertake research / analysis into the focus sectors to deepen CEFC knowledge of particular areas and consider possible solutions or implications for CEFC's strategy in these sectors.
- Sound knowledge of clean energy technologies/solutions to determine if a potential transaction is eligible or what clean energy goal CEFC would seek

Personal Skills

- Strategic thinking able to consider the broad parameters and determine how to translate that into origination ideas and/or actions
- The ability to work independently within a broad team investment the role interacts across multiple CEFC teams and the ability to integrate with various teams will be required.
- Able to represent CEFC independently at meetings. Ability to exercise sound judgment and act with integrity based on commercial experience. Demonstrate CEFC values in approach to work.
- Strong presentation skills to interact confidently with Executive/Board for investment decisions

The investment analysis skills and relevant experience is likely to be from a role with a high transactional focus or advisory role on relevant transactions:

- Financial advisory firms
- Banking sector and impact investors
- Relevant tertiary qualifications (i.e. Finance, Accounting, Business, Engineering, Law)
