

## SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD 1 JANUARY 2022 – 31 DECEMBER 2022

Pursuant to the Senate Order 13 – Entity Contracts ('Murray Motion'), the following table sets out contracts entered into by the Clean Energy Finance Corporation which meet the following criteria:

- i. provide for a consideration to the value of \$100,000 or more (GST inclusive); and
- ii. have been entered into prior to 1 January 2022 and not fully performed as at 31 December 2022; and/or
- iii. have been entered into during the 2022 calendar year.

Most of the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract.

The reasons for including such clauses include:

- a. ordinary commercial prudence that requires protection of commercial-sensitive contracts, information, trade secrets, proprietary information and the like; and/or
- b. protection of other material and personal information.
